

# Miscellaneous Family Papers Collections

## PVMA Library

The letters and documents listed in this general finding aid represent smaller collections that lack detailed finding aids. Many represent non-Deerfield families, and range in size from a single item to several folders.

### **Abell Family**

Folder 1: Letters from George Austin Abell of Conway, MA (later of Meriden, CT), to members of his family while he served in the Union Army during the Civil War, 1862-May 1863. (Many of the letters in this and the following folder are addressed to his brother, Lewis Strong Abell of Conway) (34 items)

Folder 2: Letters continued, June 1863-October 1864. Also certificate of G.A. Abell's honorable discharge, November 1864, and certificate granting his widow, Alice Holcomb Abell, a pension, 1911. (32 items)

Folder 3: Legal documents relating mainly to Joshua Abell, Sr., Joshua Abell, Jr. both of Goshen, MA; and of the latter's sons William and George of the same town, 1801-1836 and undated (18 items) (George was the father of George Austin Abell; the two Joshuas, his grandfather and great grandfather)

Folder 4: Genealogical material relating to the Abell family and to the related Holcomb, Cathcart, and Taylor families, ca. 1904-1922 and undated. (19 items)

Folder 5: Diary of George A. Abell for 1878 (in 1878 he resided in Northampton)

### **Adams, Willis Seaver**

Folder containing a catalog relating to the life and work of American artist Willis Seaver Adams (1844-1921), prepared by the American Studies Group of Deerfield Academy in 1966, in connection with a retrospective exhibit of his work at the Hilson Gallery. With the catalog: an announcement of the exhibit and two printed clippings relating to Adams.

### **Adkins**

Deed for property purchased in Deerfield by Solomon Adkins, May 1865.

### **Aiken - scrapbooks & misc.**

Items belonging to, or kept by, David and John Adams Aiken. Biographical notes taken from *The History of Greenfield*, Vols. II & III

Aiken, David, born in 1804 in Bedford, NH. Studied at Phillips Academy in Andover and graduated with honors at Dartmouth in 1830. He came to Greenfield and studied law with James C. Alvord. Passed the bar in 1833, and formed a partnership with George Grennell. He then formed the firm of Aiken, Davis & Allen. In 1856, he was appointed Associate Justice of the Court of Common Pleas, and served until 1859. He had a partnership with Chester C. Conant, W.S.B. Hopkins, and his son, John. Served as selectman in 1844, and for a portion of 1853, and state Senator in 1874. He was director of the Greenfield Bank for a time, and trustee of the Franklin Savings Institution. Aiken married Mary Elizabeth Adams of Amherst, MA, in 1848. He died April 13, 1895.

Aiken, John Adams, son of David and Mary Adams, born in Greenfield in 1850. Graduated from Dartmouth College in 1874; studied law at Harvard, and was admitted to the bar in 1876. He entered practice with his father and Chester Conant, and eventually became the acknowledged leader of the Franklin County Bar. Elected district attorney from 1889 to 1895. In 1898, he was appointed to the Superior Court and remained until his retirement at the age of 72. He married Maria Dickinson in 1895. Aiken was an officer of the PVMA and Greenfield Historical Society. He died January 13, 1927.

## **Ainsworth, Gordon Ellery**

Ainsworth (1909-1971) of South Deerfield was a registered land surveyor and a member of many professional organizations; a town moderator; trustee of Bement School and the Heritage Foundation (now Historic Deerfield); and a member of the council of the Pocumtuck Valley Memorial Association.

Items relating to Gordon Ellery Ainsworth: Obituaries published in the *Springfield Union* (August 6, 1971) and the *Greenfield Recorder* (August 5, 1971); two copies of the memorial service held on August 7 at the Congregational Church of South Deerfield.

## **Alden**

"Genealogical Notes of Some Aldens in Western Mass." Gift of William O. Taylor of Orange, Mass. (Formerly V-a no. 7246 in the PVMA library)

The notes include information copied from Mitchell's *History of Bridgewater*; Enfield, Connecticut, town records; Palmer, Mass., vital records; Springfield, Mass., Register of Deeds; and Stafford, Connecticut, probate and town records.

## Alexander

Two journals kept by Thomas Alexander (1727-1801) of Northfield, MA, the first from May 27 to October 31, 1758, when he was an ensign in Capt. Salah Barnard's Company (which marched from Deerfield on May 27); the second from March 6 to July 18, 1776 when he was a captain and led a march to Quebec. With these are transcripts of the journals.

Transcript of letter from Elias Alexander, at Fort Cumberland, to his wife, August 14, 1755.

Three receipts for taxes paid by Solomon Alexander on land in the first division of Bernardston, MA, 1778-1779.

Certified copy of certificate of Amos Alexander (who moved from Sunderland, MA, to Deerfield about 1772) in regard to a three-year old colt, July 3, 1793.

## Allis

John Allis<sup>2</sup>, born in 1642. Millwright and carpenter, who contracted to build the first corn mill at Mill River (Deerfield) in 1790(?) but died the following year before its completion. He is represented by an agreement, dated Feb. 26, 1712, among his children, legatees of his estate. (1 item).

Lucius Allis<sup>9</sup>, born in Deerfield in 1737, the son of Samuel<sup>6</sup> and Hannah (Sheldon) Allis and great grandson of John<sup>2</sup>. He settled in Whately, MA, in 1761, moving to Conway, MA, in 1764. His papers consist mainly of land deeds, but include a copy of his will (1817) and material relating to the settlement of his estate. 1764-1822 and undated. (26 items)

Solomon Allis, born in Conway in 1769, the son of Lucius<sup>9</sup> and Mary (Wells) Allis. Married Anna B. Dickinson of Hatfield in 1794. Died in Conway in 1823. His papers consist of three deeds to land in Conway, one from his father and one from his brother, Samuel; and a receipt for money spent as executor of his father's estate. 1794, 1812, 1822, 1823 (4 items)

Anna (Dickinson) Allis, wife of Solomon. Her papers consist of articles for her allowance by order of the Judge of Probate (undated); her appointment as guardian of her minor children (1824); and a life deed to one-third of her husband's home property. 1824 and undated. (3 items)

John Allis, born in Conway, MA, in 1801, one of nine children of Solomon and Anna (Dickinson) Allis. A farmer, he married Lydia Smith of Conway in 1823. He died prior to 1836. His papers consist of four deeds to land in Conway, formerly owned by his father, and a fire insurance policy. 1829-1850.

Charles Allis of Deerfield (not included in Sheldon's *History*). He is represented by a deed to land in Deerfield, purchased from Henry Stebbins in 1870.

Genealogical material mainly undated, that relates to the Allis family; Miscellany (4 items);

Correspondence with George Sheldon and others relating to the Allis family, 1876-1984.

## **Alvord**

Memorandum relating to staves sold in Connecticut, signed by Elisha Alvord in Northampton, MA, March 13, 1764 (endorsed as directed to Daniel Jones). Two receipts for taxes paid by Seth Alvord in Readsboro, VT, June 20 1798, and May 7, 1803. Letter from H. W. Taft (to George Sheldon) dated Pittsfield, MA, March 9, 1877, in which Lucy Alvord is mentioned.

## **Ames**

Deed to land in Wendell, Middlesex County, MA, sold by Cyprian How to Moses Ames of Marlborough in that county, June 1, 1801. A release by Ames to Clark Stone of Wendell, March 23, 1810, is endorsed on the verso. Recorded in 1801 by Elijah Williams and in 1810 by Epaphras Hoyt, Registrars of the North District. Letter, H.C. Payne to George Sheldon, dated Milwaukee, WI, September 30, 1898 in which he states his ancestors were early settlers of Ashfield, MA, and that he is descended on his mother's side from Ebenezer Ames of Deerfield.

## **Amsden**

Deeds and other legal documents of John Amsden of Deerfield, 1764-1797 (6 originals; 6 copies)

Execution and judgment of Asahel Amsden of Ashfield, MA, against the estate of Uriah Goodman, late of Ashfield (1 item)

Correspondence and genealogical notes relating to members of the Amsden family, 1898-1985.

Report relating to the Amsdens by Priscilla Greeley, Historic Deerfield Guide, March 26, 1984 (1 item)

## **Anderson**

David Anderson: tax receipt, 1800. (1 item)

John Anderson of Colrain, MA: receipts from David Field and Jonathan Fisk, 1771, 1774.

John Anderson of Deerfield: promissory note from John Linn, 1780, and execution and judgment against the administrators of the estate of Jonathan Ashley, 1788.

Solomon Anderson of Deerfield: Judgment against Rufus Arms, 1796.

Letters to George Sheldon re: members of the Anderson family, 1901, 1913.

## **Ayers /Ayres**

Legal documents (7) relating to the support of Jesse Ayers and his wife, Martha, of Leverett, MA, first by their son George (who abandoned them), then by their grandson, Moses Field, and finally by the overseers of the poor. Also, last will and testament of David Ayers of Colrain, MA, 1809.

## **Bailey**

Genealogical material relating to the ancestors and descendants of the Reverend Winthrop Bailey (b. Berlin, MA, 1784; d. Deerfield, MA, 1835), including three letters dated 1804 from a grandson, Arthur H. Foote, of St. Louis, MO, to George Sheldon.

## **Baldwin**

Three documents containing genealogical information by George Sheldon, relating to the descendants of John Baldwin, emigrant, of Connecticut (and particularly of his great, great, grandson John, who moved from Harwinton, CT, to Deerfield in 1804). See Sheldon's *History of Deerfield*, Vol. II, pp. 54-55.

Letter (Jan. 16, 1963) inquiring about descendants of Joseph Baldwin, emigrant, who moved from Milford, CT to Hadley, MA, ca. 1662. See Sheldon, II, p. 55.

## **Ballard**

Papers of the Ballard family of Gill, MA, consisting of three letters to Martha Ballard (1789- 1876) of Gill written from Ohio by her daughter, Laura Ballard Hillman. Also letters to Ballard from Abigail Green and Anna and Calvin Hosford. Other letters (not written by Martha) are to her daughters, Mary Almira Ballard and Mavareth Ann Ballard.

## **Barber**

Correspondence and notes of George Sheldon relating to members of the Barber family, 1872-1909. (6 items)

Manuscripts of three poems by Rev. Henry H. Barber "Col. Shaw and the 54<sup>th</sup> Mass. Volunteers," "The Passage of High Bridge," and "The Lay of Falls Fight." Also "Poem" by Eliza Hapgood Barber, 1864.

## **Barney**

Papers of Florence Barney (who married Roland Stebbins of Petersham, MA, in 1880), 1873-1886, 1938, and undated. Most of the items are letters she received, many from her uncle, M. V(an) Barney of Alton, IL, and his wife Jennie, and from her brother, Charles W. Barney who settled in

Montana. With these are two papers relating to the mortgage of a piano by her brother, Edward Barney of Greenfield, MA, Apr. 19, 1875; and a letter to her father from his son Charles, May 10, 1884. 28 items

## **Barrett**

Inventory of the estate (personal property) of Benjamin Barrett, deceased, taken by Lt. Thomas Wells and Joseph Barnard, Sept. 23, 1690, at the court in Springfield; followed by an "apprizment" of Barrett's real estate holdings and a report of the administrators of his estate (copies made from the originals Feb. 16, 1701/2 and Feb. 26 1701/2.) Genealogical notes relating to members of the Barrett family provided to George Sheldon in 1884.

## **Bartholomew**

Material relating to William Bartholomew (b. Ipswich, MA, 1640/41; d. Woodstock, CT 1697). Two are letters received by George Sheldon from George W. Bartholomew of Austin, TX, in 1882; the remaining material consists of Sheldon's research notes regarding William Bartholomew, many of the notes written on the verso of an unrelated printed galley. (See Sheldon's *History of Deerfield II*, p. 76.)

## **Bascom**

Genealogical material relating to the Bascom Family, consisting of a letter to George Sheldon from Gertrude B. Darwin, May 5, 1898, regarding the identity of the wife of her grandfather, Artemidorus Bascom; and extracts of birth, marriage, and death records re: Bascoms in Northampton, MA. (3 items)

## **Beaman**

Original will of Simon "Beamond" of Deerfield, Feb. 16, 1711/12; and original order of the Superior Court for the sale of real estate of Hannah (Barnard) Westcarr Beaman, widow of Simon, on petition of her guardians, Sept. 1737. Also typed transcripts made from records in the probate court in Northampton, MA, of the inventory of the estate of John Westcarr of Hadley (Hanna's first husband), the will and inventory of the estate of Hannah. See Sheldon, *History of Deerfield*, II, pp. 65 and 80.

Deed to land in South Deerfield purchased from Joseph L. Beaman, Heaman Beaman, and their wives, by Mary J. Fisk, Apr. 1, 1865; notes on "Hannah Beaman's Book" (*Hist. and Proceedings of the PVMA*, VI, 1921).

## **Beardsley**

Letter from Mary Beardsley (Mrs. John) Maynard to George Sheldon, asking for information re: the Beardsley family of Connecticut, 28 September 1894.

## **Belcher**

Four letters, dated 1873-74, and two sheets of genealogical notes relating to the possible, but unlikely, descent of the Belcher family of Northfield, Mass., from the Royal Governor, Jonathan Belcher.

## **Bement**

Copy in the writing of George Sheldon of a list of passengers for Virginia and the Barbadoes in which John Bement is named; birth and death dates of a number of members of the family. 2 items

## **Benjamin, Asher**

Reproduction of a typed list of books by Asher Benjamin; and of a letter from Benjamin to Postmaster General Granger, 5 August 1802, from original in the Gallatin Papers in the New York Historical Society. Numerous copies of articles and misc. about Benjamin.

## **Bigelow**

Deed (1835) for sale of property in Deerfield from Collister May to Edmund Bigelow of Springfield, MA.

## **Blakeley**

Promissory note signed by Jonathan Blakele(y) at Ashfield, MA, Jan. 3, 1771. Deed to land in Deerfield, sold by Stephen Cary, Jr., of Rowe, MA, to John Blakeley, Oct. 13, 1798.

## **Blodgett**

Two legal documents relating to land in Deerfield: (1) a deed from Silas Hawks to Joseph Blodgett, both of Deerfield, July 29, 1805; and (2) a mortgage Simeon Blodgett placed on his land in favor of Cyrus A. Stowell.

Genealogical information re; Blodgett family in exchange of letters between George Sheldon and Simeon Blodgett, Jan. 22 and Feb. 5, 1877; and one letter of Apr. 12, 1909, from Louisa T. Tiffany to George Sheldon.

## **Bond**

Damaged document, dated 1817, that consists of a list of men (mostly from Deerfield) with financial amounts next to their names. The document is titled "Seth Bond being surveyor of hig

[missing] the year 1817 has set to each mans [sic] name the Money that is expended." Apparently refers to road work in Deerfield.

## **Boyden**

Four legal documents: quit claim deed of Ambrose Boyden (1858); two deeds for land purchased by Frederick Boyden (1799, 1805, 1808). See also the separate guide to the Frank L. Boyden Papers.

## **Bradford**

Letter written in 1877 to George Sheldon detailing the ancestors of Shubael Bradford of Conway, MA.

## **Brigham**

Two deeds to land in Deerfield from Cephas Brigham of Montague, MA, (and later of Newton, MA) to Lorenzo Brigham of Deerfield, dated July 5, 1849, and Mar. 10, 1863.

## **Brooks**

Six deeds to land in Buckland, MA, from Samuel Taylor and others to Alpheus Brooks of Buckland, MA, 1790-1829. Deed to land in Buckland from Alpheus Brooks to his son and namesake, both of Buckland, MA, 1836; and agreement between the father and son, 1852. Genealogy of the Brooks family: photocopy of a 77-page compilation, given to P.V.M.A. by Beverley Brooks, Mar. 5, 1975.

## **Broughton**

Inventory of the estate of Thomas Broughton of Deerfield, 13 June 1693. Bond of John Broughton, administrator of the estate of Thomas Broughton, 27 September 1693. Letter of Jacob Kier referring to a deed conveying land from Enos Broughton to Green Adams, dated Rothville, Chariton County, MO, March 6, 1876.

## **Bryant**

Deed to land in Deerfield from Giles Hubbard to Allen Bryant, 25 November 1814. Deed to land in Deerfield from Almon and Sylvia Bryant to Kosiah Brown and Allen Bryant, 1 November 1862. Diagram of Bryant family relationships, compiled by Lester Bryant, July 1894.

## **Buckminster**

Encapsulated bond, signed by Daniel Gookin in March 1664, requiring Joseph Buckminster to appear at the next session of the county court to answer for a charge of "selling sundry liquids to the Indians & beating and wounding two of them."

## **Bull**

Yale diploma of the Rev. Nehemiah Bull, dated Sept. 1, 1723; letter, Stephen West Williams to Dr. George Bull of Shelburne, 10 June 1839; letter, Lucy Robbins (granddaughter of Dr. George Bull) to George Sheldon, asking for information about her great-grandfather, William Bull of Deerfield and later of Shelburne, MA, February 20, 1899; typewritten account relating to William Bull and Daniel Clay, cabinetmaker, compiled by Douglas Sackman from P.V.M. A. manuscript account books, 1974.

## **Burke**

Folder 1: Papers of Major John Burke (1717-1784), originally of Hatfield, MA, and later one of the first settlers of Falltown (Bernardston), MA. In 1740, he married Sarah, daughter of Jonathan and Mary (Field) Hoyt of Deerfield. He took part in the French and Indian Wars, 1744-55, and in 1777 was a member of the Committee of Safety and Correspondence. In the interval he was a tavern keeper, town clerk (1763-84), and first representative from the town to the General Court. His papers are largely receipts and deeds to land, many of the latter related to property granted those who took part in the Falls Fight. According to a memorandum with the papers, Hon. H. W. Cushman is believed to have deposited the more valuable of Major Burke's papers in the New England Genealogical and Historical Society in Boston. (77 items)

Folder 2: Papers, largely legal documents, of Major Burke's son, John (1785-1813). He was a merchant and considerable landowner in Bernardston. (33 items)

Folder 3: Papers of Lovinia Burke, widow of John Burke, Jr., the earlier papers concerned with the settlement of his estate. 21 items dated 1796-1810.

Folder 4: Papers of the three sons of John Burke, Jr. and Lovinia Burke: John (1785-1813); his wife, Roxy (Morely) Burke; Horace (1788-1815); and Daniel (1791-1822). Material dates from 1797 to 1818, and consists mainly of legal documents, but includes a copy of Horace Burke's will and a division of the personal estate of Horace and his wife Loomis.

## **Burt**

Folder 1: Documents relating to suits brought by Ithamar Burt, tailor (during the period he was a Deerfield resident) against Henry McNelly and Samuel Graham (both of Deerfield) and Andrew Colton (of Springfield, MA), 1789-1791. (7 items)

Receipt signed by Calvin Burt & Co., of Deerfield, December 20, 1798; receipt signed by Eleazer Burt, August 24, 1765; action brought by Ebenezer Burt of Deerfield against Jonathan Arms of Charlestown, NH, 1791; promissory note of Stephen Burt of Deerfield, and suit brought against him by Chester Smith of Deerfield, 1805.

Folder 2: Genealogical correspondence and notes relating to the Burt family, 1876 and later.

## **Butler**

Bound volume of genealogical notes prepared by W. O. Taylor of Shelburne Falls, MA. Preceded by Taylor's notes on the White family.

## **Buzzell**

Mortgage backed by Inhabitants of Town of Deerfield on property of Everett Buzzell in Deerfield, February 20, 1869.

## **Cantrell**

Deed to land in Deerfield from William Henry Allen of Greenfield to Benjamin Cantrell, Jr. of Deerfield, December 18, 1849.

Letter from Susan Cantrell Christie of Brooklyn, N.Y. to George Sheldon, February 1, 1903, asking for information about Cantrell family members.

## **Carver, Jonathan**

Letters received by George Sheldon in regard to Jonathan Carver, "the traveler," of Montague, MA, dated 1892-1897. (15 items). Most of the letters are from Judge Daniel W. Bond, whose letter of 12 May 1895 enclosed a 14-page memorandum on Carver. The information in this memorandum relating to Carver's ancestry was later questioned by Judge Bond. See Sheldon's *History of Deerfield*, Vol. II, pp. 101-04.

## **Chamberlain**

Incomplete letter from Harriet A. Fox of Chicago to George Sheldon, 3 January 1898, asking for information in regard to Nathaniel Chamberlain. Reproduction of obituary notice of Samuel Chamberlain, artist, in *The Boston Globe*, 11 January 1975; and two copies of the order of burial and celebration of Holy Eucharist in Saint Michael's Church in Marblehead, MA, 14 January 1975.

## **Chandler**

Four legal documents by and against Moses Chandler of Deerfield, 1771-1792. (4 items). Bond of David Chandler, son of Moses of Deerfield, obliging him to repay Matthew Clesson of Deerfield and Samuel Doane Cook of Greenfield, MA, money he borrowed, 6 November 1787. (1 item)

Letter, with enclosed list, from T. D. Seymour Bassett, Curator of the Wilber Collection at the University of Vermont Library, to Mary Wells, Director of the P.V.M.A., in regard to writings of Amariah Chandler, a younger son of Moses. (1 item)

Manuscript sermon of Rev. Amariah Chandler (1782-1864), son of Moses Chandler above, and a pamphlet, *Amariah Chandler and His Times*, by Francis M. Thompson (published by PVMA and read at the annual meeting in 1909). Amariah Chandler was born in Shelburne, MA, and was a minister in Waitsfield, VT, and Greenfield, MA (2 items)

Telegram regarding the death of Thomas Goodnough, father-in-law of Amariah's son, Joseph Whitney Chandler, (who married Adaline Goodnough, daughter of Thomas Goodnough). (1 item).

17 July 1909. Letter from Mrs. Thomas Zoglman of Wanpun, WI, to Mrs. Boyden, 5 June 1969,

## **Chapman**

1850 Dec. 10: Deed to land in Deerfield from Haziel W. Smith to William Chapman.

1855 Nov. 1: Deed to land in Deerfield from Charles Hitchcock, as guardian of minor children, to Samuel Chapman, Jr. and Salmon Chapmen.

1860 Apr. 3: Mortgage on land of Samuel Chapman, Jr., conveyed to Rev. John F. Moors.

1864 Nov. 5: Deed to land in Deerfield from Samuel Chapman to J.W.D. Osgood of Greenfield, MA.

1870 Oct. 27: Mortgage on land of Samuel Chapman conveyed to Franklin Savings Institution.

## **Church**

1800 May 26: Two judgments each recovered by Samuel Church and Lemuel Clarke of Sunderland, MA, against George Tracy of Deerfield.

1916 Aug. 24: Letter, Mrs. Elizabeth C. Sheldon of Abbeville, GA, asking for information relating to the descendants of Richard Chapman of Hartford (of whom one, Samuel, was said to live in Deerfield).

[1967]: Letter from Mrs. Keith F. Cordrey of Newport Beach, CA, asking for information relating to the Henry Church family.

## **Clapp**

Manuscript patent letter (1802) for a crank engine signed by James Madison; letter of Joseph Clapp (1810) selling his rights to manufacturing the engine to Elisha and Erastus Clapp, and Frederic Boyden of Deerfield; letter (1812) to Erastus Clapp and Frederic Boyden from Robert Herrick of Clinton [NY?], wishing to purchase or have made an engine; two damaged handbills offering the purchaser the rights to manufacture the engines in New York; printed *Description of Clapp's Patented Crank Engine* (Greenfield, 1811).

## **Clark**

Genealogical information by Moses Montague, a great grandson of Ebenezer Clark, one of six brothers whose surname was Clark, all residents of Northampton, MA.

Lease of land in Colrain, MA, by Amasa Clark to William Clark and his wife Mary, all of Colrain, 6 July 1803; New Year's greeting from Henry and Julia Clarke of Seattle, WA, 1973.

Genealogical information, typescript 8 pp., references, facsimiles, etc. on the John Clark family of Colrain and Hatfield, especially John, b. Ireland c. 1704. Gift of Ross L. Jacobs.

Obituary of Frederick G. Clark of Clarkdale Fruit Farms, Deerfield, May 2005.

## **Clarke, Henry Leland**

Biographical information from his April 1992 obituary and *The International Cyclopaedia of Music and Musicians*.

Henry Leland Clarke, son of Ward R. and Annie (Barber) Clarke, was born March 9, 1907, in Dover, NH. Educated at Harvard, Clarke received his bachelor, master's, and doctoral degrees in music. He taught at U.C.L.A. and U. of Washington, and became a well-known composer. His compositions include pieces for orchestra, chamber music, chorus and voice, and theatre. Clarke was a WWII veteran and member of the All Souls Church in Greenfield, MA. He married Julia Kaesby of New Jersey in 1937; they had one daughter, Anne, who died in infancy. Clarke died on April 22, 1992. He and his wife are buried in Laurel Hill Cemetery in Deerfield.

He was a 1928 graduate of Deerfield Academy. He married Olga Kostecky. Frank worked for Luey and Abercrombie grocery business of Greenfield before enlisting in the service in 1942. During WWII he became a sergeant, was seriously injured, and left the service as a disabled veteran, unable to work when he returned home. He and his wife lived in Montague, MA, but returned to build a house in Deerfield on a lot on the Dahowski farm. They were members of the Holy Ghost Ukrainian Catholic Church in South Deerfield. Olga (Ollie) worked at Greenfield Tap and Die during the war, and at LaPierre's Electrical Store in Greenfield. They are both buried in the St. Stanislaus Cemetery, South Deerfield.

Theodore Kosteky (Kostecki) was born in Austria in 1874 and came to New York in 1900. He lived with his sister in New York and was a tailor. He married Mary Czerniawska in 1902: they moved to Sunderland, MA, and later lived in Montague and East Deerfield where they farmed and sold tobacco and fruit. He was a founder of the Holy Ghost Ukrainian Church, donating funds to help build the structure. After his death, his wife and a daughter lived in S. Deerfield, until Mary died in 1950. Their daughter Olga, born in 1910, married Frank R. Dahowski, Jr. (above) in 1947.

Born in Northfield, MA, in 1834, James K. Hosmer attended Harvard and was ordained minister of Deerfield's Unitarian Church in 1860. He served in the Mass. 52<sup>nd</sup> Regt. In 1862 and 1863; his experiences in the war resulted in two books: *The Color Guard* (1864) and *The Thinking Bayonet* (1865). Hosmer taught at Antioch College, Yellow Springs, Washington Univ., St. Louis, and became Librarian of the Minneapolis Public Library. His papers consist of correspondence (mostly with George Sheldon), a lengthy biographical sketch, photocopy of a history of the Minneapolis Pub. Lib., newspaper notice of a lecture, and a list of subscribers to *The Thinking Bayonet*.

Other Hosmer papers include correspondence and wedding notice of Ralph Sheldon Hosmer, ordination exercises for George Herbert Hosmer, and a death notice of Francis J. Hosmer.

## **Houghton**

Documents relating to various individuals. Includes correspondence with George Sheldon on Holton genealogy, material on the Church of the Transfiguration (NY City), and an 1814 letter from Clark Houghton to Orlando Ware of Deerfield.

## **Howe**

Documents relating to various individuals. Deed of land in New Salem MA, purchased by Solomon Howe; letters to George Sheldon regarding Howe genealogy; and printed notice for Caroline Belle Howe, "reciter."

## **Howe, Margery Burnham**

A group of 50 items dated 1962-65 and 1973-77, composed mainly of letters addressed to Mrs. Howe. These contain information she sought while researching her book, *Deerfield Embroidery* (N.Y., Scribners, 1976) as well as a few comments after publication of the book.

Her principal correspondents were Julie Sutphen (reporting her success in following Miss Whiting's recipe for indigo dyeing); Mary Glaze, curatorial assistant of the American Wing of the Metropolitan Museum of Art; Mrs. Holton (Ina Miller) Thorn, who lived in the Miller household in Deerfield as a girl, providing information about some of the procedures followed by Miss Miller and Miss Whiting; H.J. Purple of Frederick J. Fawcett, Inc., importers in Boston (regarding yarns); and Doris Thatcher of Cold Spring, NY.

Many of the letters describe attempts to identify the Ruth Culver Coleman who designed and worked the two coverlets now in the Metropolitan Museum. There is also genealogical information on Sarah Snell Bryant and Koturah Baldwin, whose work is included in Mrs. Howe's book. One letter (March, 14, 1974) furnishes information on the place of burial of Miss Margaret Whiting. See also "Deerfield Business and Commerce" in the subject oriented manuscript guide for items re Deerfield Society of Blue and White and Deerfield Industries. Obituaries and the extensive funeral program for Mrs. Howe are included.

Fol. 3 - Papers of Caleb Hubbard (1754-1850) of Sunderland, MA. Includes land deeds, a contract for the sale of cattle from Lydia Smith of Leverett, MA, an 1831 document signed by the proprietors of pews of the Sunderland meetinghouse making an unspecified claim against the First Parish of Sunderland, document granting his widow, Lucretia, a pension for Caleb's service in the American Revolution, a letter from his brother-in-law, Lemuel Clarke, regarding debts, and a letter from his nephew, Martin Field, asking financial support for Caleb's nephew, Lucius Hubbard, studying at Harvard.

Fol. 4 – Papers of Israel Hubbard (1725-1817) of Sunderland, MA. Includes a summons against Robbard Smith based on a complaint by Hubbard, deeds, a sale of land in Sunderland, and a document describing the payment of taxes on land owned by John Chandler of Petersham, MA, giving Hubbard the right of possession.

Fol. 5 - Accounts of Lucy Stearns Hubbard (1727-1816) of Hatfield, MA, relating to the estate of her dead husband, Elisha (1721-1768) and other accounts beginning in 1769. Also a 1795 estate document to her daughter, Sarah, wife of John Chapman.

## **Keith, William and Jane W.**

A deed for land in Deerfield which they purchased from Mary W. Fogg and Josiah Fogg, July 27, 1859.

## **Keith, William Scott, Eliza (Howe), and Elizabeth S.**

A card which was to have been the New Year's card of Eliza H. and William S. Keith in 1969; and copies of the order of service at St. James Church in Greenfield for the burial of William Scott Keith (January 1969), his daughter Elizabeth S. Keith (October 1980) and his wife, Eliza Howe Keith (January 1984). Mrs. Keith was a member of the council and treasurer of the Pocumtuck Valley Memorial Association for many years.

## **Kellogg, Joseph (1691-1756)**

Correspondence with George Sheldon, 1898-1901, and "Deerfield librarian," 1960, principally concerned with Joseph Kellogg, government interpreter to the Indians. Also included are handwritten copies of a memorial from Joseph Kellogg to the General Court of Massachusetts and other action before the Court on his behalf.

## **Kendall, Lyman (1784-1847)**

1. Quit-claim deed to land in South Deerfield which he received from Wells Lathrop and Daniel Willard, both of Springfield, MA, Jan. 18, 1830.
2. Two typescripts: excerpts from the journal of Lyman Kendall, including an account of his years as a merchant in Greenfield, Massachusetts, 1810-1828. (One typescript was received as a gift from Judge Francis M. Thompson of Greenfield).

## **Kennedy**

Mortgage deed from Thomas and Joanne Kennedy of Deerfield to Enos B. Wills of Worcester, MA, Mar. 26, 1856. (According to endorsement, Enos Wills paid the amount of the mortgage and obtained title to the land in Deerfield.)

## **King (and related Smith family)**

A group of papers of the King family of New Salem, MA, including papers of Samuel King, Jr., his son Eliphalet King, the latter's son Rawson King and wife, Martha Emma (Smith) King, and Eliphalet's brother, Joseph King. 1858-1916. (24 items).

In a separate folder filed with the above are papers of the Smith family of South Deerfield, including material related to the military service of Joseph Smith and his son Henry Smith. (Henry's daughter, Martha Emma, married Rawson King of New Salem. See Sheldon, *History of Deerfield*, II, p. 309, for relevant genealogical information.) 1794-1871 – 8 items.

## **Kingman**

Deed to land in South Deerfield, purchased from I. J. Riley Maynard by Alfred M. Kingman, Mar. 28, 1862. (1 item). Photocopy of letter to Deerfield Academy, May 7, 1977 from Helene Kingman Preble, daughter of Elbridge Kingman (born in Ashfield, MA), seeking the name of her grandfather; and penciled information supplied. ## **Kingsley**

A group of papers of the Kingsley family, including Haines Kingsley of Westfield., MA, and his wife Susannah (including a copy of Haines' will in 1750 and papers relating to the settlement of his estate in 1755); his brother, Jonathan Kingsley of Northampton, MA, his nephew and namesake, Haines Kingsley of Northampton (including his appointment as guardian of three Frost children) consisting mainly of deeds and other records of land in Northampton, 1738-1798. (38 items).

## **Knowlton, Charles**

Postcard to George Sheldon from George Littlefield suggesting reference to Dr. R. M. Lawrence of Boston for information on Captain James Lawrence, Nov. 28, 1913.

## **Lincoln, Luther B.**

Commonplace book of Luther B. Lincoln, containing notes that appear to have been written while a student. He was born in Westford, MA, in 1802, graduated from Harvard in 1822, and served as principal of Deerfield Academy, 1835-1844. He married Susan Barker Willard in 1831; the couple built a house on the minister's lot (no. 7) in Deerfield in 1850. Was Deerfield's representative to

the state assembly in 1854. He died in 1855. Material donated by his daughter, Mary Willard Lincoln.

## **Lipp**

Lloyd Herbert Lipp was born 1879; died 1965. He married Ellen Wells Stebbins of Petersham, MA, in 1905. She was born in 1883, daughter of Rowland Stebbins, and died in 1980. The couple lived in Pawnee, Nebraska. Their first son, Frederic, was born in Billings, Montana. Frederic married June Rhea McDonald in 1938 and had 2 children. Robert, born c. 1915, resided in Old Greenwich, CT.

## **Loomis, Nathan**

Mathematical notebook of Nathan Loomis (b. 1794) with verse dated Ashfield, MA, March 5, 1815. The son of Rev. Jonah and Susannah Howes Loomis of Ashfield, he attended Sanderson Academy. Nathan was the grandfather of Mabel Loomis Todd of Amherst, MA. Gift of Ruth Wyman, 1984

## **Loveridge**

Deeds to land in Deerfield sold to John Loveridge of Deerfield, Aug. 17, 1842 and Mar. 31, 1852. (2 items).

Mr. McCloud was a teacher in public schools in Pennsylvania and New Hampshire for 18 years, and worked as a substitute teacher in Greenfield schools. He was an amateur historian and genealogist. His papers were a bequest to P.V.M.A.

## **Miller, Amelia Fuller and Russell A.**

Russ (d. 1989) taught at Deerfield Academy and served as President of the Pocumtuck Valley Memorial Association's Council. Mimi (1926-2003), his wife, worked as a researcher for Henry Flynt and Historic Deerfield, wrote numerous articles and several books, and also served as PVMA's President.

Their papers largely consist of obituary notices, a small amount of correspondence, and the appraisal of Mimi's father estate in Cincinnati (1939). Amelia Miller's extensive research files are shelved separately.

## **Newcomb**

Hezekiah Newcomb of Bernardston, MA. Manuscript copy of his will, dated Nov. 6, 1817. Gift of Mrs. R. H. Lindquist, 1982.

Charles Jarvis Newcomb (son of Hezekiah and residual heir to his estate). Typed sheet of information about him, supplied by Mrs. Sheldon Howe.

Horatio Newcomb (another son of Hezekiah). Original commission as postmaster of Winchendon, Worcester Co., MA, June 21, 1817. Gift of Mrs. R. H. Lindquist, 1982.

## **Parker**

Martin Phelps account for wheat and cider, 1754, 1755, 1761-1762, 1771. Mortgage deed from Timothy A. Phelps and Charles Phelps of Deerfield to Emmaline Bourne of Northampton, MA, for land in Deerfield to be held by her sole and separate use (1759). Endorsed as discharged in 1789.

## **Phillips**

Six legal documents relating to actions against Daniel, Joshua, Phillip Richard, and Thomas Phillips, all of Ashfield, MA. Fourteen letters from Hart Phillips of Hoosick Falls, NY, to George Sheldon containing information on the Phillips family and forwarding donations to Memorial Hall Museum, 1887-1894. Includes partial typewritten list. (See Sheldon, II, 261 for information relating to Hart Phillips). Bound volume inscribed by "Mollie A. Phillips" (i.e., Mary A. Deed to land in Deerfield purchased by Martin Sauter from Henry Clapp in 1863.

## **Savage**

Record book of childhood, titled *Baby's Kingdom*, kept by the parents of Helen Abel Savage, born Jan. 12, 1901.

## **Scott**

Will of William Scott of Hatfield, MA, dated Feb. 1716/17; will of Joseph Scott of Hatfield, Dec. 1744; two receipts (1768, 1769) to Aaron Scott of Deerfield from Ezekiel Bascom for weaving; two complaints against Aaron Scott (both 1773) lodged by Ezekiel Bascom for non-payment.

## **Seares**

Deeds to land purchased by Daniel, Enos, and William Seares of Ashfield, MA, 1802-1848 (14 items).

## **Smith, Sarah**

Papers, primarily copies, relating to the trial of Sarah Smith (d. 1698) executed for infanticide, and her complaint against John Evans of Deerfield of rape.

## **Smith, William E.**

Widow's pension application and copies of supporting documents. Smith (1853-1918) served in the Seventh Regt., U.S. Calvary and was with Gen. Marcus Reno at the battle of the Little Bighorn, 1876.

## **Sprague, Ephraim**

Deed for land in Deerfield purchased by Sprague in April 1818.

## **Spring, John G.**

Deed for land in Deerfield sold by Spring in Dec. 1855

## **Starkweather**

Papers of Charles Starkweather (1759-1843) of Northampton, MA, and his grandson, Charles Graves Starkweather (1819-1906). Include land deeds and transfers (1788-1861), receipts, and Charles' last will and testament (1843). 39 items.

## **Stratton, Elijah (Northfield)**

Receipts, accounts, promissory notes, and deeds to land purchased by Elijah Stratton of Northfield, MA, 1786-1834 (48 items).

## **Stratton Family (Northfield)**

## **Strong**

Typescript reminiscence, dated 1941, of Rev. David H. Strong (1856-1942); copy of Simeon Strong's probate inventory, dated March 1806.

## **Swan**

Three receipts (all 1791) of Benjamin Swan of Deerfield; photocopy of genealogical notes.

## **Sweet**

Two (both 1791) warrants against Joshua Sweet of Deerfield for trespass and non-payment of debt, conveyance of real property to satisfy the debts of Sweet (1792), promissory note from Sweet to Gad Smith (1803); receipt of Ebenezer Sweet (1784); modern correspondence regarding members of the Sweet family.

## **Taintor**

Four land deeds: Alexander (1824), Josiah (1859), Obadiah (1837, 1844).

## **Thayer**

Lists (8) of the children of several members of the Thayer family; four deeds for sale of land of Edward Thayer of Conway, MA (deceased) by his son to pay Edward's debts;

## **Thompson, Francis N.**

Papers, mostly poetry, of Judge Francis N. Thompson (1872-1948) of Greenfield, MA.

## **Thorn**

## **Tracy, George**

Judgement against George Tracy of Deerfield for debt owed to Samuel Church and Lemuel Clark of Sunderland in the amount of \$27.43, dated May 1800.

## **Trask**

Brief genealogical record of the Trask family, with photocopies of photographs, by Charles Stebbins; single page hand-written record of the Jesse Trask family; deed for purchase of land by Selah B. Trask of Deerfield, 1850.

## **Trowbridge**

Writ for non-payment against Daniel Trowbridge of Buckland by Moses Stebbins of Conway, Dec. 1789.

## **Viles/Ward**

A small collection of miscellaneous papers relating to the family of Emeline Viles (1819-1900) of Lexington, Massachusetts, who married John Sanderson Ward in 1847. The papers include mostly receipts from Emeline's mother, Betsey. Also included are receipts from Emeline's attendance at Deerfield Academy, and a detailed listing of furniture in a house.

## **Waite**

Papers of David, William, and George Wait(e) of Deerfield, and Seth Wait of Ashfield, MA. Included are deeds for land sales, complaints for damages, receipts, and modern correspondence regarding the Waite family.

## **Waite, Benjamin (Hatfield)**

Original four-page 1670 court document (and photocopies) of a charge of selling liquor to Natives.

## **Ward**

Letters of Graham Ward to Jonathan Ward of Buckland, MA, 1841, 1843 (3 items)

## **Ware**

Papers of Orlando Ware (1779-1860): Deed to property in Deerfield sold in 1808; detailed rental agreement for part of his house (1807); judgement against Daniel Burnham of Montague, MA (1819); complaint against Daniel Burnham for unpaid debt (1818); complaint of theft against Cyrus Brown; complaint against Morris Hervey for goods sold (1819); lease of property in Deerfield from Ebenezer Williams (1833); misc. receipts (9).

Papers of Edwin Ware (1802-1870): deeds to property sold in Deerfield (1853, 1861, 1867); liquor license (1865); letter regarding his last will and testament (1871); business correspondence (3 letters); misc. receipts (15); letter written to Fanny Ware, 1830.

## **Ware, Anna Maria (b. 1833) of Shelburne Falls, MA**

A large group of original and copied poetry, some sketches and watercolors, and a few printed items, mostly dating from the 1840s.

## **Warren**

Miscellaneous papers of Joseph and Timothy Warren of Ashfield, MA, and George W. Warren of Deerfield. Includes the last will and testament of Rhoda Warren of Deerfield, mother of George, dated 1886.

## **Washburn**

Three manuscript speeches (with typed transcriptions) and one letter to the editor of the *Springfield Republican* of Mass. Governor and U.S. Senator, William B. Washburn (1820-1887). Washburn lived for a time in Greenfield, and one speech was given at the 1870 dedication of the Civil War monument on the town common. Also the catalogue of the stamp collection formed by William N. Washburn of Greenfield, sold at auction in Nov. 1918.

## **Webster**

Receipts of Stephen Webster of Bernardston, 1782, 1801, 1803.

### **Weeks, Levi**

Photocopies and transcripts of material relating to Levi Weeks (1770-1819), an architect who lived in Deerfield after being tried and acquitted for murder in New York City in 1800. He later lived in Natches, Miss., where he designed several homes.

### **Weld, Daniel**

Last will and testament of Daniel Weld of Deerfield, dated March 1700.

### **Wells (Shelburne Falls, MA)**

Business correspondence and receipts of E. Wells & Co., 1869-1870 (6 items)
